Articles of Agreement made and entered into the twenty fifth day of August in the year of our Lord one thousand eight hundred and seventy nine between Eva Cora Tilton wife of Stephen Parker Goddard of Hereford in the District of St. Francis Province of Quebec said Stephen Parker Goddard being present to specially authorize the said Eva C. Tilton his said wife for all and every the purposes hereof A.D. one thousand eight hundred and seventy nine as well appear by his signature hereto of the one part, and Henry P. Goddard of said Hereford of the other part, in the manner following to wit: That is to say that is to say the said Henry P. Goddard his heirs, Executors and Administrators shall and will well and truly pay or cause to be paid unto the said Eva Cora Tilton her heirs, Executors and Administrators the full sum of six hundred and twenty five dollars as follows Eva Cora Tilton her one hundred dollars in the month of October 1880 and interest from date at the rate of Eight per centum one hundred dollars in October 1881 with annual interest at the same rate from date to say that is the said the same sum in 1882 with annual interest from date at the same rate the same sum in 1883 with annual interest from date at the same rate the same sum in 1884 with annual interest from date at the same rate the same sum in 1885 with annual interest from date at the same rate and twenty five dollars in 1886 with annual interest from date at the same rate.
